Vocational Rehabilitation assists individuals to evaluate their skills related to employment.

We match an individual's skill set to the appropriate job or fund training to update skills necessary for employment.

### **Customized Job Driven Training Programs**

- Meet with employer to identify employment needs
- Develop job driven training plan utilizing employer information relevant to open positions and requirements
- Identify qualified and motivated MRC Consumers seeking a career as pharmacy technician
- RESUMate: Database for matching candidates for jobs and training programs
- Prepare MRC consumers with a thorough vetting process to include mock interviews and pre-training modules



## **CVS** CAREMARK

MRC Consumers who were hired through our customized Pharmacy Tech program *nearly doubled our retention rate locally.* 

Average cost of turnover: \$2,900 per Pharmacy Tech 60 Pharmacy Techs hired through this program. Total training cost savings to the company of over \$60,000. WOTC: potentially >\$75,000 Cost to CVS Health of 4 cycles of training to date: <\$1,000





#### **JDT Candidates:**

- Opted into JDT due to interest in the work and/or employer
- Graduates presented to the employer have met JDT attendance expectations
- Immersed into curriculum specific to (and ideally provided by) employer
- Prepared for hiring process, workforce through job readiness training
- Want to be engaged in a role that is part of a career path

# Traits employers want to see in candidates:

- Enthusiastic about company, brand ambassador
- Reliable, dedicated
- Ramp-up time reduced, less chance that unknown that could lead to turnover
- Knowledgeable, prepared, supported both internally and externally
- Desire to learn, grow with organization

**Implementation of Best Practices** 

- MRC Candidates Identified, Vetted, and Mock Interviews
- MRC prepares candidates for specific positions within The Home Depot job categories
- MRC candidates participate in Job Driven Training Program at The Home Depot (various locations across the state)

#### **Implementation of Best Practices (Cont.)**

- The Home Depot provides detailed information about work environment, job requirements and job expectations
- Candidates move forward with the on-line application and hiring process
- Candidates are offered job after background check

#### **JOB DRIVEN TRAINNG**

#### **Implementation of Best Practices (Cont.)**

- Once hired the employee begins orientation and continues with on-line training modules for approximately two weeks
- MRC Job Placement Team continues to work with The Home Depot representatives and MRC Consumers/employees to ensure success

## JOB DRIVEN TRAINING (JDT) RESULTS\*

- 75 MRC Candidates Registered and Participated in the JDT
- 45 Placements
- 35 Successful Employment Outcomes (90+ Days)











